## Letter of Agreement regarding the Heretaunga Tamatea Deed of Settlement

This letter follows communication between my officials and Heretaunga Tamatea Settlement Trust regarding an amendment required to the Heretaunga Tamatea Deed of Settlement (the deed).

As my officials discussed with you, it has come to their attention that Wai 1583 Pukehou and Other Blocks (Kiripatea) Claim has been incorrectly recorded in the deed as Wai 1853. It appears this error was made in the Heretaunga Tamatea Agreement in Principle and carried over into the deed.

In order for the settlement legislation to provide for the correct claim to be settled the deed must be amended to correct this error. Clause 8.2.2(dd) of the deed therefore requires amendment to read "Wai 1583 Pukehou and Other Blocks (Kiripatea) Claim".

In accordance with clause 5.1 of the General Matters Schedule of the deed this amendment must be agreed in writing by Heretaunga Tamatea Settlement Trust and the Crown.

I therefore request that you and the other trustees review the proposed amendment above and, if you agree, return this letter counter-signed to the Office of Treaty Settlements. Once signed, this letter will be uploaded on the Office of Treaty Settlements website to accompany the deed.
