Tēnā koe [name]

Crown and Hineuru Treaty Settlement – relationship with [core/non Crown agency]

I am writing to advise the [core/non Crown agency] of the signed Treaty settlement with Hineuru and to introduce Te Kōpere o te iwi o Hineuru Trust (**Te Kōpere**), the post-settlement governance entity mandated to receive, hold and manage the settlement assets for the iwi, and the entity who entered into the Deed of Settlement with the Crown.

As part of the Treaty settlement process, the Office of Treaty Settlements (**OTS**) often writes letters to relevant Crown agencies after settlement to introduce the settled group. The aim is to set a foundation for an effective and durable relationship into the future. I also hope future engagement will enable [core/non Crown agency] to better understand how Te Kōpere fits into your service area.

Hineuru

The people of Hineuru descend from the rangatira Apa Hapaitaketake. Hineuru herself lived about 11 to 14 generations after Apa Hapaitaketake. The descendants of Hineuru eventually moved from their original lands, in and around Putauaki at Whakatane to the Pohukura, Runanga, Tatarakina and Tarawera areas. There they established the tribal identity, Hineuru. Their key claims relate to the confiscation of land in the 1867 Mohaka-Waikare Confiscation, subsequent Crown title investigation of land blocks, the loss of land, and the social and economic effects of the landlessness on the iwi. We attach an introductory note from Hineuru that explains who they are, they rohe, and their aspirations for the future. We also attach a copy of the Hineuru Area of Interest so that you may get an understanding of the Hineuru rohe.

Settlement of historical claims

The Crown initialed a deed of settlement (**Deed**) with Hineuru for the settlement of their historical Treaty of Waitangi claims in July 2014 and signed a Deed of Settlement on 2 April 2015. The Deed will be conditional on settlement legislation (to be introduced into the House of Representatives following signing of the Deed). Te Kōpere is the main contact for Hineuru in post-settlement. I wish you well with your future relationship with Te Kōpere.

This paper provides a brief background to who we are as Hineuru, our rohe/Area of Interest, and our settlement.

Our people

Our people descend from our eponymous ancestress Hineuru (through her first marriage to Kiripakeke). Hineuru were originally a section of an early descent group known as Ngāti Apa, the descendants of Apa Hapaitaketake. Today, however, we are a distinct iwi in our own right and are centred on the Runanga-Te Haroto district, with our marae at Te Haroto.

Our rohe sits across the arterial route between Napier and Taupō and borders the following hapū and iwi groups:

- Maungaharuru-Tangitū Hapū;
- Ngāti Pāhauwera;
- Tūhoe;
- Ngāti Manawa;
- Ngāti Whare;
- Tūwharetoa;
- Ngā iwi o Mōkai-Pātea; and
- Ngā hapū o Ahuriri.

Hineuru occupied a substantial and strategic position which straddled the North Island main divide. Our lands include both sides of the upper Mohaka valley, and the headwaters of the Waipunga river. At the core of our territory was the Tarawera corridor, an area of dense settlement, numerous

villages and extensive cultivations up to the time of the confiscation of large sections of Hineuru's lands by raupatu under the New Zealand Settlements Act 1863.

The start of our ill fortunes began when a number of our Hineuru people went to Omarunui in 1866, just outside Napier to meet with a Crown representative Donald McLean. After some days the encampment was overwhelmed by the Crown and its Māori allies. Many of our people were killed and those who survived were taken into custody and sent into exile in the Chatham Islands, 500 miles out to sea, and left there until such time as the colonial government saw fit to allow them to return home.

Our Rangatira Te Rangihiroa was killed near Petane in 1866 following an attack by Crown forces, on the same day as the battle of Omarunui. Following these attacks our villages were pillaged by Crown forces and those who had not gone on the expedition to Omarunui fled into the North Island interior beyond the limits of the Hawke's Bay provincial boundary.

At this time our Hineuru people were scattered, some at various places beyond the boundary, while others, willingly or not so willingly, were with Te Kooti's whakarau after escaping from the Chatham Islands and were being pursued by Crown forces through the North Island interior. Having suffered severe losses at Omarunui, more Hineuru people died at Ngatapa and other places. Our chief Nikora was identified when his severed head was brought into the camp, to be lamented over by his sister. His wife, who was with him when he died, was placed in the custody of the Crown's Māori allies.

In 1867-70 the Crown confiscated a large part of our lands through the New Zealand Settlements Act and further specific legislation.

Over the next few years our remaining Hineuru lands were transferred to other iwi and sold, often to the Crown, whilst our Hineuru people were in no position to oppose or object to its loss. The events of the past have contributed to the significant, long term, economic, social and cultural detriment of our iwi.

Today, our iwi are essentially landless; by various means, our once extensive rohe has all but disappeared. Hineuru were confined to Te Haroto. The Te Haroto block was reallocated to Hineuru in 1910 and since then has been occupied by the iwi; however, in its current state, it cannot support our people.

As a direct consequence of our tumultuous history our iwi were physically, emotionally and spiritually displaced.

Our Settlement

Our settlement has been tailored for the people of Hineuru first and foremost to recognise our troubled history and to reflect the seriousness of our claims. We have now established a settlement governance trust – Te Kōpere o te iwi o Hineuru – to receive, hold and manage our settlement.

The future for Hineuru

Our settlement is based on six key pou or pillars that we believe will be the foundation of building a strong, vibrant Hineuru iwi that is recognised as the kaitiaki of our region, that is a strong economic player in the region, and an iwi that is supporting our own people culturally and socially. Our pou are noted below with a brief description on what these pou mean for the future of Hineuru:

Pou 1

Restoration and protection of our cultural heritage and history for our future generations.

Pou 2

Restoration of the health and wellbeing of our people.

Pou 3

Recognition of the mana of Hineuru and restoration of the relativity Hineuru had with other iwi of the region.

Pou 4

Reassertion of the presence of Hineuru through our rohe.

Pou 5

Rebuilding an economic base for Hineuru.

Pou 6

Revitalisation and restoration of our role as kaitiaki of our resources and environment.

Pou 1: Through this settlement we seek to begin to restore our cultural heritage and safeguard this heritage for current and future generations. We wish to build a strong iwi that is immersed in their Hineuru values and culture.

Pou 2: Looking forward, we hope to improve the physical and subsequently the cultural health of our people using the settlement as a foundation to do that.

Pou 3: As a consequence of Crown intervention, Hineuru have been classified and labelled, up until recently, a hapū of other iwi in the region. Through this settlement, we seek to begin to reinstate our mana as tangata whenua relative to other iwi and to lay a foundation for a positive relationship in true partnership with the Crown. One way we see this happening is recognition through the census of Hineuru as an iwi.

Pou 4: Hineuru are often excluded as an iwi from publicly available material such as census material. This settlement provides recognition by the Crown of our mana through physical means such as the return of lands, as well as recognition based Treaty settlement redress. We wish to build further on this platform in the future.

Pou 5: Our settlement will see Hineuru receive up to \$50 million of assets including cash, land, forestry, and buildings. In a short period of time, Hineuru will become a big economic player in the region with excess of \$35 million in cash. Through this settlement Hineuru wish to rebuild an economic base in our region with a view of having inter-generational investments that are of benefit to our people, and our regional and national economy.

Pou 6: Our natural environment, as the source of our sustenance and nourishment, forms another of our key cornerstones. Through this settlement, Hineuru will have greater involvement in the management of resources within the rohe as the rightful kaitiaki of this area. We see our relationship agreement with the Department of Conservation as a platform to further enhance our ability to be kaitiaki in our rohe.

We are looking forward to working with all agencies to help us and support us in our future endeavours as we work towards building a brighter Hineuru future for our tamariki and mokopuna.
