






4 CONSERVATION FRAMEWORK AREA MAP






Diagram B: Part Mangapiko Valley Scenic Reserve





Diagram C: Part Hapuakohe Ecological Area







9 SPECIFIED AREA PROPERTIES MAP




10 TAURANGA RFR LAND MAP



11 WENTWORTH VALLEY PROPERTY




12 LICENSED LAND MAPS














Whangapoua Crown Forestry Licence


13 TAIRUA FIRE STATION LAND EXCHANGE MAP




14 MANGATANGI, MANGATAWHIRI AND WHANGAMARINO CATCHMENTS MAP
